

## ICA Opposes Attempts to Expand Doctors of Chiropractic Scope of Practice to Include the Prescribing of Dangerous Drugs and Administration of Natural Substances Under Certain Circumstances

Recent legislative activities in Florida warranted the ICA to issue a Public Statement focused not just to Florida legislation, but to all similar attempts.

The principle concern of the International Chiropractors Association (ICA) is the risk to public safety related to an expansion of scope of practice that would allow doctors of chiropractic to 'administer' (via injection) dangerous 'articles of natural origin' (that currently require a medical prescription).

#### The ICA has three primary concerns:

- 1. The inherent risks to patients.
- 2. Misleading language being promoted to state legislatures.

3. Substandard educational programs being used to promote new prescribing rights for chiropractors.

**Background:** In recent years there have been increasing attempts in state legislatures to modify state laws to allow doctors of chiropractic to "administer articles of natural origin" and to authorize licensed pharmacist "to fill such chiropractors orders for articles of natural origin." Examples of natural substances described in at least one pending bill states that doctors of chiropractic who have completed continuing education courses may, "store, possess, prescribe, and administer articles of natural origin, including vitamins, minerals, amino acids, fatty acids, hyaluronic acid, enzymes, saline, anti-oxidants, dextrose, glandulars, cellular components, extracts, water, botanicals, phytonutrients, and homeopathics."

# Update

## ICA Submits Follow Up Evidence to the WFC from 2019 Complaint

January 21, 2020: In the Spring 2019, The ICA filed a formal complaint to the World Federation of Chiropractic (WFC) related to events including unprofessional and offensive comments made during a presentation at the WFC's Berlin meeting.

ICA President, Stephen Welsh, DC, FICA in submitting the official complaint "As a member association of the WFC, the ICA cannot stand by while direct insults to all chiropractors that focus on the correction of the subluxation are hurled from a global stage. Such a public display of intolerance undermines the credibility of the entire profession."

ICA received a response from the WFC some months later. After extensive review and evidence gathering, the ICA has submitted our follow up evidence, validating our original complaint. In submitted the ICA response, Dr. Stephen Welsh wrote:

"In summary, the International Chiropractors Association has determined that the Board of Directors of the World Federation of Chiropractic has not adequately addressed the original complaint against two members of the WFC Research Council. It is the conclusion of the ICA that the WFC Board has failed to acknowledge the breach of its own "Principles of governance for WFC office holders" and has failed to "... challenge poor behavior whenever it occurs" as required by those "Principles" adopted by

# **Our Time Is Now**

There has never been a better time to be a chiropractor ... and now is the best time to be a member of the ICA.

As we begin the celebration of the 125<sup>th</sup> anniversary of the founding of our profession, it is an excellent time to assess where we as a profession have come from ... and where we are going ... with the ICA leading the way.

Since its inception 125 years ago, chiropractors have served as an alternative to conventional medicine. Based upon the PHILOSOPHY that the body is a self-healing organism, we have become the largest drugless healthcare profession in the world by focusing on the chiropractic adjustment and removing interference from the nervous system in order to promote the restoration of health. For 94 years the ICA has advocated that the best interests of the public is served by maintaining chiropractic as a separate and distinct, drugless, non-surgical alternative form of health care.

#### OPPORTUNITY: THE POLITICAL LANDSCAPE IS CHANGING ... IN THE UNITED STATES

The "Opioid Crisis" combined with the growing acceptance of the public, has finally brought us to the "tipping point." Policy makers at both the national and state levels are now seeking solutions to a problem that we know was created by an over dependence on pharmaceuticals. Patients are rejecting high cost, high risk interventions and seeking more natural strategies to maintain their health.

The days of blindly following the MDs orders are over. "Evidenced-based, Non-pharmacological options" are now in vogue and are being added to clinical practice guidelines at an ever-increasing rate. State legislatures have become the new battleground as organized medicine attempts to get laws passed that mandate greater use of their products while patients demand freedom of choice and more coverage from third party payors for the non-traditional (non-drug based) forms of healthcare.



#### THREAT: THE EFFORT TO "CONTAIN" CHIROPRACTIC CONTINUES ... OUTSIDE THE UNITED STATES

Forty-four years ago, it was the ICA that led the way with the filing of the anti-trust lawsuit against the American Medical Association (AMA). Ultimately the courts decided that the AMA had violated the Sherman Act, and had engaged in an unlawful conspiracy "to contain and eliminate the chiropractic profession."

A permanent injunction was issued to prevent such behavior in the future. Their battle to "eliminate" the chiropractic profession was lost, but the efforts to "contain" our profession continues to this day ... from outside the United States. One only has to look at recent events in Canada, Australia and Northern Europe to realize that there is a growing movement to limit our profession to treating neck and back pain only. Researchers and academics from outside the United States are now arguing that subluxation-based chiropractic is not evidenced-based and that there is no plausible evidence to support the premise that a chiropractic adjustment can affect the nervous system and result in an improvement in general health.

To date, the Board of Directors of the World Federation of Chiropractic has failed to take action against members of the WFC Research Council that have attempted to politicize research in order to marginalize chiropractic as practiced by the majority in the United States. Unfortunately, there are some from within our profession that seem willing to abandon the chiropractic principle in a quest for greater "cultural authority."

#### IT IS TIME TO CHANGE OUR CULTURE

For the past 125 years our profession has been divided. There have always been at least two groups that seem to take opposing public positions on issues. Policy discussions quickly degenerate into ACA vs ICA discussions, or straight vs mixer debates. Some organizations refuse to collaborate while they publicly criticize those that do. Some organizations disengage when they don't get their way, preferring to play the "It's my way or the highway" game.

As a community, it is in our best interest and the best interest of those we serve that we change our culture. It is time to recognize that as an industry our profession is competing in the health care marketplace and our greatest competitor is still organized medicine. It is time to stop circling the wagons and shooting in. It is time to learn to respect all of our colleagues with a DC degree, even those who practice with a different philosophy. It is time to admit that most chiropractors, whether they choose to operate in a traditional, vitalistic subluxation model or in a mechanistic, allopathic back pain model are providing a valuable service to their patients. It is time to commit to profession-wide collaboration and respectful dialogue on policy issues.

To be clear, respecting all philosophies is not to be interpreted as a suggestion that we add drugs and surgery to our profession scope of practice; because neither I, nor the ICA support undermining chiropractic in this way.

#### PUTTING THE EMPHASIS ON INTERNATIONAL

There are now twice as many chiropractic educational programs outside the United States as there are within. Sadly, most do not teach a subluxation focused curriculum. Some are publicly proclaiming that subluxation should be relegated to the history books. No other international organization is engaging on this matter.




## Plan to Attend the 125<sup>th</sup> Founder's Day Celebration at the Chiropractic Fountainhead

## ICA Opposes Attempts to Expand Doctors of Chiropractic Scope of Practice to Include the Prescribing of Dangerous Drugs and Administration of Natural Substances Under Certain Circumstances

legislators by those promoting these changes are misleading. Three terms are particularly problematic – 'administration', 'chiropractic orders' and 'of natural origin':

• The phrase "of natural origin" is not a regulatory term per se. Articles of natural origin range from opium, amniotic fluid being marketed by some as a stem cell treatment, dextrose, as well as vitamins and minerals. If taken orally, many of the products 'of natural origin such as vitamins,



botanicals, minerals, dextrose, and water fall into federal food and dietary supplement regulations overseen by the US Food and Drug Administration (FDA) and do not require a prescription or a pharmacist to dispense. Many homeopathic oral remedies are available 'over the counter' as well. Homeopathic medicines fall into a unique regulatory category at the FDA. Prescribed homeopathic medicines are a complex and highly specialized field separate from chiropractic, for which a few hours online or in a continuing education program would be inadequate to address the nuances of prescribing non-OTC homeopathic remedies.

• The term 'chiropractic orders' is simply a term for a medical prescription written by a Doctor of Chiropractic. Any "natural substance" that is not available "over the counter" and can only be obtained from a pharmacist is, by definition, "a dangerous drug".

• The term 'administration' is so broad that it also includes injectable products. The route of 'administration' determines the level of regulation applied at the federal level. By federal food and drug law, any product including products of natural origin that do not require a prescription for the oral product, become prescription drugs if they are administered by needle or IV. The term administration can be interpreted by regulators to include not only topical application, and oral administration, but also administration by injection (needle or IV). Examples of products that can be sold with and without a prescription or 'chiropractic order':

• Water is a perfect example. Water to drink does not require a prescription. Products that contain water and are administered topically such as saline contact lens solutions are regulated by the FDA as over the counter (OTC) drugs. Products containing water (such as Saline) that are administered through a needle including IVs are regulated by the FDA as prescription drugs. They require a prescription. This regulatory

status is critical to the establishment and management of quality control measures in manufacturing and distribution including of compounded pharmaceuticals. Compounded substances of natural origin produced without stringent FDA oversight have resulted in serious adverse outcomes for patients. Six months ago, the FDA created a Compounding Risk Alert Website noting there have been serious adverse events and deaths.(https://www.fda.gov/drugs/human-drug-compounding/compounding-risk-alerts)

• Dextrose tables are common OTC products used by individuals with Type 1 diabetes when blood sugar levels become dangerously low. Dextrose that is delivered via a needle (injected or by IV) is a prescription drug.

**Substandard Training:** The Council on Chiropractic Education (CCE) is the recognized accrediting body for the chiropractic profession. Special medical training, including lengthy and intensive medical residency programs, are normally required in order to be granted the authority to write prescriptions for dangerous drugs including substances of natural origin that will be delivered via injection. At present, there are no CCE accredited chiropractic educational programs that provide this very specialized training. ICA opposes a scope of practice expansion of something as potentially harmful as drug prescribing and injecting based on any educational program

not accredited by CCE nor tested for by the National Board of Chiropractic Examiners.

Risk to Patients: Authorizing new medical procedures not included in the regular curricula of CCE accredited chiropractic programs poses a danger to the public.

ICA also opposes extending the scope of practice of chiropractors to grant prescribing rights or to administer invasive techniques such as injections in any manner that circumvents the responsibility of the appropriate Medical and Pharmacy Boards to ensure the safety of the public.

## ICA Submits Follow Up Evidence to the WFC from 2019 Complaint

the WFC Council in September 2015.

Although the International Chiropractors Association acknowledges the September 24, 2019 announcement of the approval of a new set of guiding principles, the ICA would like to remind the WFC that any set of principles are meaningless if the organization behind them fails to act in accordance with those principles when circumstances warrant

The ICA has considered your request to retract its accusation regarding the offensive statements made by the Research Committee Chair and decline that invitation. We stand behind the original complaint.

After a careful review of the WFC letter of August 19, 2019 the ICA has determined that the WFC has mischaracterized the nature of its complaint and has inappropriately made assertions about the ICA complaint that cannot be left unaddressed."

Dr. Welsh's cover letter included a lengthy attachment providing point for point response and photographic evidence confirming the basis for ICA's complaint. In addition to requesting that the WFC sanction the presenters, the ICA in this response the ICA requested the WFC Board of Directors to issue a statement that: • "Subluxation-based" chiropractic is consistent with "evidence-friendly" chiropractic practice;

• Diversity of philosophical beliefs and clinical approaches is valued by and welcomed in the WFC;

• Any comments not representative of those principles, or implications of disapproval or disrespect for subluxation-based approaches that were made during the presentations in Berlin, were not appropriate, will not be repeated, and those making them have been admonished;

• The Policy adopted by the WFC Assembly of National Chiropractic Associations in Paris on May 23, 2001 will be displayed on the WFC Website in its listing of official WFC Policy Statements; and

• All doctors practicing within the legal scope of chiropractic in their jurisdictions are welcome to attend, present and be represented on the governing and research bodies of the WFC.

ICA will continue to stand firmly in support of our worldwide members who practice vitalistic, subluxation-oriented chiropractic. We believe that a resolution to this matter with the WFC is possible and look forward to resolving this in 2020 in a way that is best for the WFC, the ICA and the profession as a whole.


fessional Development from 1992 until her untimely passing in 2016.

## ICA Submits Comments to CMS Regarding Executive Order on Improving Medicare

January 22, 2020 (Falls Church, VA) On January 16, the ICA submitted comments to the Centers for Medicare & Medicaid Services (CMS) per their request for information. CMS is tasked with making changes after President Trump issued Executive Order #13890 titled, "Protecting and Improving Medicare for Our Nation's Seniors". The Executive order specifically directs the Department of Health and Human Services to propose reforms to the Medicare program, related to scope of practice in particular where Medicare is more stringent than other applicable federal or state laws.

Using our Medicare Framework as the foundation of our submission, we used this opportunity to address the discriminatory barriers to access for chiropractic and offered very specific recommendations. We reminded CMS that existing barriers remain in Medicare regulations and policies in 2020 that linger from the remnants of the decades long restraint of trade discrimination actions against the chiropractic profession that was affirmed in 1987 in the federal courts. (Dr. Chester A. WILK et al., Plaintiffs, v. AMERICAN MEDICAL ASSOCIATION et al., Defendants-Appellees).

We noted the benefit of adopting the verbiage of Section 2706 of the Public Health Service Act (42 U.S. Code § 300gg– 5) into all CMS managed programs including Medicare. This language states, "A group health plan and a health insurance issuer offering group or individual health insurance coverage shall not discriminate with respect to participation under the plan or coverage against any health care provider who is acting within the scope of that provider's license or certification under applicable State law." And coupled this recommendation with the following: "To be clear, the ICA does not support the expansion of our profession's scope of practice to include drug prescribing, in fact we vehemently oppose any such actions. Drug prescribing is incongruent with our profession."

We noted that by implementing this change and providing specific clarity that the following services that support the correction of the subluxation through the chiropractic adjustment, CMS can improve care for seniors, remove barriers to access, and end decades of discriminatory policies and practices. And provided the following specific change requests:

- Exams, Evaluation and Management, and Radiological (x-ray) Services be covered
- Clarification that both acute and chronic conditions are covered
- Freedom of Medicare Beneficiaries to Privately Contract (the Opt-Out Provision) be allowed; and that
- Chiropractors receive parity in rates of compensation as other physician level providers for exams, x-rays/imaging, and other covered benefits.

ICA continues to work on Capitol Hill to seek legislative changes; but also believes that President has opened a door for CMS to make our requested changes.

ICA President, Dr. Stephen Welsh stated, "Executive Order # 13890 has given CMS a unique opportunity to improve access to chiropractic care through an accelerated regulatory process. With our submission, the ICA has provided a roadmap to both improved care for our seniors as well as lowering costs to Medicare."

## **NBCE Student Leadership Forum**

In January 2020, the National Board of Chiropractic Examiners (NCBE) invited student representatives to their campus in Greeley, Colorado. The goals of the meeting were to discuss their systems and receive feedback about the student experience with NBCE exams. Kelly Kimball, ICA Student Intern, Palmer Student, ICA leader, and pending Palmer Chiropractic College graduate, was among the student leaders selected to attend the meeting on behalf of the Student ICA. Below is her summary of discussions at the event:

#### NBCE considers three stakeholders and their interests:

1. Students: NBCE works hard to create valid, fair, and standardized exams in order to maintain a uniform, high standard across the profession. They also provide the convenience of having one board exam that is valid in every state, so that state-specific board exams are not required for licensing.

2. Chiropractic Colleges: NBCE scores provide information required for each college's accreditation. NBCE also provides performance feedback to each college.

3. State Boards: NBCE is committed to providing each state board with a product that protects the board legally, protects the public, and that the board feels comfortable using to set the standard of the profession in that state.

#### Some myths, debunked!

None of NBCE's exams are graded on a curve. Questions have different weights based on their difficulty, and once a student has earned enough credit from the questions they have answered, they pass the exam.

Why the wait on scores, then? Exams results are analyzed statistically to ensure that each question was valid, fair, and standardized. More information on this can be found at: <u>https://</u> <u>mynbce.org/understanding-scores/</u>

No questions are "thrown out" during the analysis of exam results. Upon finding a question that did not test well, the key could be edited to give credit for more than one answer, but no questions are removed entirely. (However, there are a few



new questions being "tried out" on each exam, which never count towards the student's score.)

Choosing to use or not to use hand sanitizer has no impact on your Part IV score. Students are also not responsible for ensuring that their patient has clean face paper during the Part IV exam.

While professors may claim they "teach something because it's on boards," NBCE claims that question formation works in the opposite direction: they test on what is taught. If there is something that is not taught consistently across the schools, it will not be on NBCE exams.

#### **Changes NBCE is implementing:**

Students will now receive scheduling reminder emails every two weeks when they have paid for, but not yet scheduled, their exam. And, in order to minimize noise during the exam, instructions for computer-based testing will now be given in the hallway instead of whispered to the examinee at the computer.

#### One exciting announcement:

NBCE has paid for the production of a 30-second commercial which will air five times during the Tokyo Olympics! This commercial is being coordinated by the Foundation for Chiropractic Progress and will debut at Parker Seminars in Las Vegas this February. It details the story of an Olympic athlete who had a profound experience with chiropractic after an injury, using chiropractic not just to recover but also improve overall performance.

After the commercial has aired during the Olympics, it will be made available for any chiropractor to use in their practice, on their website, etc. NBCE sees this commercial as beneficial to the entire profession by generating interest in becoming a chiropractor, generating interest in becoming a patient, and by presenting chiropractic to the largest group of viewers in the world with a message that chiropractic is not just for pain, but effective for improving overall performance.
